

CITYWIDE TRENDS

CITYWIDE ENROLLMENT (DISTRICT AND CHARTER), 2013-14 TO 2022-23

New York City Public Schools (NYCPS) is committed to thoughtful collaboration with districts and communities to collectively strengthen schools, support students and families, and respond to demographic and population changes in New York City.

• K-12 enrollment in District 1-32 schools and charter schools has declined by about 12% since its peak in the 2016-2017 school year, exacerbated by population changes during the COVID-19 pandemic.

DISTRICT PLANNING PROCESS

- The Office of District Planning partners with communities, superintendents, and other stakeholders to identify solutions that address district needs, in accordance with Chancellor's Regulations A-185 and A-190.
 - **Chancellor's Regulation A-185** governs the process to re-zone or unzone schools in partnership with and voted on by Community Education Councils (CECs).
 - Chancellor's Regulation A-190 governs the process to make any major changes to school utilization such as co-locations, school mergers, grade expansions and truncations, re-sitings, and other changes. A-190 proposals are voted on by the Panel for Educational Policy (PEP).

- There have been relatively few major school changes in District 8 in recent years.
- The Virtual School has a presence at building X840 but does not serve students there.
- For 2023-2024, a new District 75 elementary school program is opening in building X048 in Hunts Point.

 - Are students remaining in the district to attend school? If not, where are they going?



- Over the last five years, total enrollment in District 8 declined by 18%.
- From the previous school year, total enrollment in District 8 declined by 3%.
- The decline is most pronounced at the elementary school level, where enrollment has decreased by 24% over the past five years.

DISTRICT SCHOOL ENROLLMENT




District 8 Schools - K-5 and 6-8 Enrollment

- Since the 2019-2020 school year, district elementary school enrollment in District 8 declined by 17%.
- Since the 2019-2020 school year, district middle school enrollment in District 8 declined by 11%.
- These declines are less steep than the borough-wide declines, which are 29% at the elementary school level and 16% at middle school.



- Over the past five years, the number of elementary school-aged children in District 8 declined by 17%.
- District elementary school enrollment has declined by 25%, and the share of residents enrolling in district schools declined by six percentage points.
- Charter school enrollment increased by 9%, and the share of residents enrolling in charter schools increased by six percentage points.
- Non-Public School enrollment decreased in line with the population, and the share of District 8 students enrolling in non-public schools remained stable.
- The shift from district to charter schools is present in greater numbers at the borough level.




- Over the past five years, the number of middle school-aged children in District 8 declined by 5%.
- Both elementary and middle school retention in District 8 is 50-60%, which places the district in the middle of the pack in the Bronx.
- Twenty-four percent of District 8 elementary and middle school students attend charter schools, which is similar to the borough average.
- In District 8, 56% of elementary school students and 52% of middle school students choose to attend district schools in District 8.

Middle School Students




% of Students Attending Home District Middle Schools



Middle School Students – District of Residence





- Ninety-one percent of students attending elementary and 81% of middle school students attending District 8 schools reside in the district.
- A large number of students attending D8 middle schools come from District 12. The schools in building X123, J.H.S. 123 James M. Kieran (08X123) and The School for Inquiry and Social Justice (08X337), are the closest middle school option for many D12 students.



- The percentage of pre-K students leaving NYC or enrolling in non-district school options for kindergarten remains stable.
- The number of students articulating from Pre-K in District 8 to District 8 schools declined by 22%.
- Discharges to charter and non-public schools also decreased.
- The decrease in number of discharges and overall share of students articulating to district schools are in line with borough averages.


- The percentage of 5th grade students leaving NYC or enrolling in non-district school options for 6th grade increased by 3 percentage points.
- The share of students discharged after 5th grade grew by four percentage points, as the overall number of 5th graders and the number articulating to District 8 schools for 6th grade have both decreased.
- Boroughwide, the number and share of students discharged after 5th grade have grown slightly.

- Two elementary and three middle schools in District 8 are in the bottom 25% of enrollment citywide.
- P.S. 130 lost 46% of its enrollment over the past five years. The zone retention rate declined from 63% to 29% over this time.
- Bronx Mathematics Preparatory School and M.S. 301 serve fewer than 200 students.



- The elementary schools with the first, second, and fourth highest demand, as well as the highest demand middle school, are located in the eastern section of District 8, toward Throgs Neck.
- P.S. 69, the third highest demand elementary school, is located in a small, dated facility and uses a Temporary Classroom Building and an Annex.

SEAT DEMAND

- We consider the total number of students and the total number of seats to see if there is a net surplus or deficit of seats within a district.
- Some districts, and particular areas within a district, struggle with over-utilization, while others have excess capacity.
- Guiding Questions:
 - Are there certain parts of the district with significant excess space? Areas of crowding or over-utilization?
 - How does projected enrollment compare to capacity and how do we expect that to change over time?
 - o Do projections align with current, on-the-ground experience?

- The addition anticipated to be completed in 2024 at X138 allows for the opportunity to alleviate overutilization across District 8.
- District 8 is expected to continue to have excess K-5 seat capacity over the next year.
- Currently there are roughly 2,000 excess seats at each of the elementary and middle school levels.

BUILDINGS & CAPACITY

SCHOOL & BUILDING UTILIZATION WITHIN THE DISTRICT

- The Office of District Planning works closely with the School Construction Authority (SCA) and the Office of Space Management to understand how buildings are currently used and how capacity can best be used in future years.
- Each year, the SCA publishes the Blue Book, a tool that analyzes the capacity of each NYCPS building across the City and compares the target capacity with the number of enrolled students to determine a utilization rate for the building.
- <u>Guiding Questions:</u>
 - Given the current and projected capacity trends presented in the preceding Demand and Capacity section, does the district have sufficient capacity to meet its needs and support its students?
 - o Is over- or under-utilization concentrated at a particular grade level? In a particular area?
 - Are there under-utilized buildings with excess capacity to accommodate an additional school or program?



DISTRICT 8 UNDER-UTILIZED BUILDINGS




Under-utilized Buildings in District 8 with 300+ Excess Seats

- Utilization rates do not always capture the full narrative of space in a building but provide a starting point for assessing potential space availability. For example, some buildings, although under-utilized, may not have sufficient space to add another school.
- Other buildings with significant excess seats could be candidates to address pressing district needs, including housing another school or adding or expanding programs such as dual language offerings, District 75 programming, Autism Spectrum Disorder (ASD) programs, Gifted and Talented, and/or other district needs.
- Building X450 has 1,495 excess seats, the most excess space of any building in District 8.
- Building X048, which has the most excess seats of any building serving elementary school, will be the site of a new District 75 program in 2023-24.



DISTRICT 75

- NYCPS's District 75 provides highly specialized instructional support for students with significant challenges, such as ASD, significant cognitive delays, emotional disturbance, sensory impairment, and multiple disabilities.
- District 75 serves students through a number of different program models designed for students of different ages and education needs.
 - Most District 75 students attend Special Class programs, which operate as distinct schools and may be located in standalone sites or co-located with district schools
 - A smaller number of students attend Inclusion Programs, in which students receive District 75 services within general education classes at a district school partner.
- Guiding Questions:
 - Does the district have a need for more District 75 seats?
 - Are there potential options for new D75 sites to provide opportunities for students to attend programs closer to their homes?


District 8 D75 Special Class Enrollment by Year

- There is a 25-seat deficit of District 75 middle school seats and a 253-seat deficit of District 75 high school seats in District 8.
- The number of students in District 8 who need a District 75 seat has remained stable at the elementary and high school levels and decreased at the middle school level over the past three years.
- The new District 75 program at X048 will add 48-96 elementary school District 75 seats to D8.




- Roughly 2/3 of elementary and middle school students in District 8 are Hispanic which is in line with the Bronx average.
- District 8 serves a higher percentage of Black students than the Bronx average.
- District 8 serves lower percentage of Asian and White students compared to city average.

- All but two District 8 elementary schools and all D8 middle schools have Hispanic majorities.
- The two that don't are P.S. 36 and P.S. 583, located in Unionport. These school have large Asian populations.
- Schools located in the Western part of District 8 (such as P.S. 93 and P.S. 146) tend to serve larger Black populations, while those in the Eastern part (particularly P.S. 14 and P.S. 71) serve greater numbers of white students.



K-5 Race/Ethnicity, Schools Serving ES Grades




6-8 Race/Ethnicity, Schools Serving MS Grades



• Seventeen percent of District 8 students are English Language Learners. This is about the same as the borough average.




