

CITYWIDE TRENDS

CITYWIDE ENROLLMENT (DISTRICT AND CHARTER), 2014-15 TO 2023-24

New York City Public Schools (NYCPS) is committed to thoughtful collaboration with districts and communities to collectively strengthen schools, support students and families, and respond to demographic and population changes in New York City.

- Enrollment in D1-32 schools remained stable in 2023-2024 after declining by about 12% in the three school years since the onset of the COVID-19 pandemic.
- Overall, K-12 enrollment in District 1-32 schools and charter schools has declined by about 11% since its peak in the 2016-2017 school year.

DISTRICT PLANNING PROCESS

- The Office of District Planning partners with communities, superintendents, and other stakeholders to identify solutions that address district needs, in accordance with Chancellor's Regulations A-185 and A-190.
 - Chancellor's Regulation A-185 governs the process to re-zone or unzone schools in partnership with and voted on by Community Education Councils (CECs).
 - Chancellor's Regulation A-190 governs the process to make any major changes to school utilization such as co-locations, school mergers, grade expansions and truncations, re-sitings, and other changes. A-190 proposals are voted on by the Panel for Educational Policy (PEP).

• Guiding Questions:

- How might recent changes affect the needs of the district as they are implemented? Do they address key needs and priorities?
- O What other school changes could be considered?


- P.S./M.S. 47 was re-sited from Stella Maris (Q593) to a new replacement building (Q343) in the beginning of the current school year.
- Waterside Children's Studio School was subsequently re-sited to Q593 to provide the school with additional capacity in a newly renovated building designed to house an elementary school.

DISTRICT ENROLLMENT TRENDS

UNPACKING ENROLLMENT TRENDS

- Enrollment is a key data component in the District Planning Process. Enrollment data helps us identify trends, generate hypotheses, and understand where we need to dig deeper in partnership with our stakeholders.
- Guiding Questions:
 - What has happened to district enrollment over the last six years overall? By incoming grade (Kindergarten, 6th grade, and 9th grade)? Are there notable trends?
 - o Are students remaining in the district to attend school? If not, where are they going?

- Since the 2018-2019 school year, district both elementary and middle school enrollment in District 27 have both declined by 14%.
 - o However, elementary school enrollment increased in the 2023-2024 school year.
- Over the same period, elementary school enrollment across Queens has declined by 14%, and middle school enrollment has declined by 10%, showing comparable enrollment loss in District 27 when compared to the rest of the borough.



- Over the last five years, total enrollment in District 27 has declined by 8%.
- Elementary school enrollment had a significant decline between 2018-2019 and 2022-2023 but enrollment increased 3% between 2022-2023 and 2023-2024, indicating potential stabilization.
- The overall rate of decline peaked at 5.4% between the 2020-2021 and 2021-2022 school years, but between the 2022-2023 and 2023-24 school years there was an overall increase across 3K-12 enrollment of 1.5%.



Residential population is presented here as the sum of students attending any NYCPS school, charter or non-public school; as such, this metric will not capture students who are home schooled, have dropped out, or are otherwise not enrolled in these school options.

- In District 27, the number of K-5 residents has decreased by approximately 12% and middle school residents has decreased by about 10% over the last five years.
- The decline in district school enrollment over the same period is 14% on both the elementary and
 middle school levels, which is slightly higher than the rate of residential loss. The indicates that while
 residential loss is a large contributing factor to enrollment loss in the district, there are also families
 choosing other options over District 27 schools.



- Over the past five years, the number of elementary school-aged children in District 27 has declined by 12%, as described on the previous page.
- The share of residents in this age group enrolling in district schools in District 27 and non-public schools have both decreased by 2 percentage points, while the share of residents enrolling in charter schools has grown by 4 percentage points.
- Enrollment choices on the elementary school level have otherwise largely stayed about the same.




- Over the past five years, the number of middle school-aged children in District 27 has declined by 10%, as described on page 6.
 - The share of middle school residents enrolling in charter schools has grown 4 percentage points in the same period, while the share of residents enrolling in district middle schools has shrunk by 3 percentage points.
- 68% of both elementary and middle school residents choose to attend district schools in District 27.

- The primary driver of the decrease in elementary and middle school enrollment in District 27 district schools is a decline in the number of residents.
 - However, fewer residents leaving the district for other district schools helped mitigate the impact of the decline in residents.
- Although the number of middle school residents leaving the district has stayed about the same, the number of residents leaving for charters has grown, while the number of residents leaving for nonpublic schools has shrunk.
- Also on the middle school level, less students are enrolling in District 27 schools from outside the district.








- The portion of 8th grade students enrolling at a district school outside of District 27 for 9th grade has declined by 5 percentage points, and a slightly larger share of students are staying in the district for 9th grade.
- The portion of 8th grade students leaving NYC or enrolling in non-district school options for 9th grade has remained largely consistent over the last four years.

- The District 27 elementary schools in the bottom 25% of enrollment are designed small and do not have building capacity to expand.
 - P.S. 51 and Lighthouse Elementary are in the bottom 25% of enrollment, but neither school has capacity in their buildings for enrollment growth.
- P.S./M.S. 47 and M.S. 53 are on this list, but both have seen enrollment increases over the last five years. The number of applicants at P.S./M.S. 47 in particular shows high demand, given the number of available seats and the zone size.
- Enrollment at KAPPA VI (27Q282) has remained stable over the last five years.
- Enrollment at Waterside School for Leadership (27Q318) has declined 31% over the last five years, but has increased 2% since 2022-2023, potentially indicating stabilization.

- The tables below include the highest demand schools at kindergarten and 6th grade in the district based on applications.
- Examining high demand schools can help identify models or programs that may be serving students well and inform other changes in the district through the planning process.

- Between Fall 2023 and Fall 2024 admissions, demand increased at P.S. 60, P.S./M.S. 114, P.S. 62 and Hawtree Creek.
- P.S. 108 has a Gifted and Talented (G&T) program, which likely contributes to high demand.
- Scholars' Academy is a 6-12 school with significant unmet demand.

ENROLLMENT VS. CAPACITY

- We consider the total number of students and the total number of seats to see if there is a net surplus or deficit of seats within a district.
- Some districts, and particular areas within a district, struggle with over-utilization, while others have excess capacity.

- The P.S. 96 addition and the new elementary capacity at Q509 (formerly Saint Mary Gate of Heaven) will address the existing elementary school seat deficit in mainland District 27.
 - o Currently there is a deficit of approximately 250 seats at the elementary school level.
- District 27 is expected to continue to have excess 6-8 seat capacity over the next several years.

BUILDINGS & CAPACITY

- The Office of District Planning works closely with the School Construction Authority (SCA) and the
 Office of Space Management to understand how buildings are currently used and how capacity can
 best be used in future years.
- Each year, the SCA publishes the Blue Book, a tool that analyzes the capacity of each NYCPS building across the City and compares the target capacity with the number of enrolled students to determine a utilization rate for the building.
- Guiding Questions:
 - Given the current enrollment and capacity, does the district have sufficient capacity to meet its needs and support its students?
 - o Is over- or under-utilization concentrated at a particular grade level? In a particular area?
 - Are there under-utilized buildings with excess capacity to accommodate an additional school or program?



UNDER-UTILIZATION IN DISTRICT 27





- Utilization rates do not always capture the full narrative of space in a building, but provide a starting
 point for assessing potential space availability. For example, some buildings, although under-utilized,
 may not have sufficient space to add another school.
- Other buildings with significant excess seats could be candidates to address pressing district needs, including housing another school or adding or expanding programs such as dual language offerings, District 75 programming, Autism Spectrum Disorder (ASD) programs, Gifted and Talented, and/or other district needs.
- Q410 (Beach Channel) and Q400 (August Martin) are both high school campuses with multiple colocated schools and programs in each building.

- Q438 is a standalone District 75 site that houses 11 sections of P.S. Q256.



- NYCPS's District 75 provides highly specialized instructional support for students with significant challenges, such as Autism Spectrum Disorder (ASD), significant cognitive delays, emotional disturbance, sensory impairment, and multiple disabilities.
- District 75 serves students through a number of different program models designed for students of different ages and education needs.
 - Most District 75 students attend Special Class programs, which operate as distinct schools and may be located in standalone sites or co-located with district schools.
 - A smaller number of students attend Inclusion Programs, in which students receive District
 75 services within general education classes at a district school partner.
- Guiding Questions:
 - O Does the district have a need for more District 75 seats?
 - Are there potential options for new District 75 sites to provide opportunities for students to attend programs closer to their homes?





District 27 District 75 Special Class Enrollment by Year





RACE/ETHNICITY




K-5 and 6-8 Enrollment by Race/Ethnicity




6-8 Race/Ethnicity, Schools Serving MS Grades






Students with Disabilities (K-8)




