### **Background and Planning Context**



# **Current LIC Elementary School Admissions Methods**

- All elementary schools serving LIC residents are zoned except for P.S. 384.
- P.S. 384 is currently a nonzoned school that serves as an overflow site for students zoned to P.S./I.S. 78.
- Residents of the Queensbridge Houses are currently zoned to eight different elementary and two different middle schools.
  - Kindergarten residents are zoned to schools up to 2.4 miles from the center of Queensbridge Houses.

### **Working Group Recommendations**

**Recommendation 1:** "Current school assignment in D30 LIC is not working for community members, and to address school assignment challenges we recommend the NYCDOE start the rezoning process."

**Recommendation 2:** "We recommend that these priorities/values be emphasized in the rezoning process:

- Providing access to a school that kids live close to, but also a school that they want to go to;
- Prioritizing diversity in schools;
- Addressing and not perpetuating inequities, including those produced by the historic zoning processes used for Queensbridge;
- Providing students with equitable education across the district, including through additional programs, resources, and more school choice for families.
- Conducting an engagement process responsive to involved communities, using a variety of outreach strategies."



### **Scenario Planning**

- Throughout Summer and early Fall 2022, ODP conducted analysis and developed re-zoning scenarios based on feedback from the community engagement process.
- ODP, Dr. Composto, and CEC 30 discussed several potential scenarios based on this feedback, as well as historic demand trends, available space, and target building capacities.
- Potential options included:
  - Re-zoning to create a zone for P.S. 384;
  - Re-zoning to create a zone for P.S. 384 with a Diversity in Admissions (DIA) admissions priority; or
  - P.S. 384 remains un-zoned with priorities for students zoned to P.S./I.S.
     78 and DIA.

#### Recommendation

- In collaboration with Superintendent Composto, ODP recommends P.S. 384 add a Diversity in Admissions priority for the incoming Kindergarten cohort.
  - Applicants who live in NYCHA housing would be prioritized for 20% of the Kindergarten seats at P.S. 384.
  - The remaining kindergarten seats (80%) would continue to be prioritized for students zoned to P.S./I.S. 78.
  - The goal of this change is to increase access to high demand schools for students who have been historically marginalized by admissions policies, particularly residents of Queensbridge Houses.
  - Additionally, this DIA priority would be expected to bring P.S. 384 closer to the average demographic averages of LIC elementary schools.

# Impact on Future Elementary School Students in District 30

- There is no impact to students currently enrolled at in grades
   K-5 at a District 30 school.
- Families who list P.S. 384 on their application who live in NYCHA housing would receive first priority to 20% of Kindergarten seats at P.S. 384 during the matching process.
  - There is an existing question on the Kindergarten application that asks for this identifier.
  - The Kindergarten application for the 2023-2024 school year closes on January 20<sup>th</sup>.
- Based on enrollment trends, new capacity planning, and continued community engagement, a re-zoning can be considered in future years.

## **Appendix**



### **Appendix 1: Definitions**

- A zoned school is a school that gives priority to attend based on residence within a defined geographical area, known as a zone.
  - Students residing in the geographic area zoned for a particular school ("the zone") are entitled to a seat at that school.
  - Zones are drawn with the goal that they contain the appropriate number of residents for a school's size, based on recent public school enrollment trends.
- An admissions priority gives certain students priority access to a school but does not entitle them to a seat.
  - Diversity in Admissions (DIA) priority: some schools give an admissions priority to applicants who are low-income, English Language Learners (ELLs), are in the child welfare system or live in temporary housing.
